# NOTICE OF PROPOSED CONSOLIDATION

RBR Group (ASX: RBR "RBR" or "the Company") advises it is proposing to undertake a consolidation of the issued capital of the Company on a thirty (30) for one (1) basis ("Consolidation"), subject to receiving shareholder approval at the Annual General Meeting scheduled to be held on 26 November 2025 ("Annual General Meeting").

The Company proposes the Consolidation for the following reasons:

- 1. The Company currently has 3.441 billion Shares on issue and 0.587 billion unquoted Options on issue, which represents a relatively large number when compared to its ASX-listed peer groups; and
- 2. the Consolidation will result in a more appropriate and effective capital structure for the Company and a share price more appealing to a wider range of investors, particularly institutional investors.

The Consolidation will be applied equally to all shareholders and as such, each shareholder's proportional interest in the Company's issued capital will remain unchanged (other than minor variations resulting from the rounding of fractional shareholdings).

The RBR Board will be recommending that shareholders vote FOR the proposed Consolidation.

### Effect on capital structure

The effect the Consolidation will have on the Company's capital structure is set out in the table below.
