## Appointment of General Manager - Operations

Mine and industrial camp accommodation and labour services specialist, RBR Group Limited (ASX: **RBR** or **the Company**), is pleased to announce the appointment of Greg Raaff as General Manager – Operations, of the Company.

Mr Raaff will be based in Perth and his appointment, effective immediately, is an important step for the Company as it expands its capacity to meet increased demand from the oil and gas industry in Mozambique, and potentially neighbouring Tanzania and Zimbabwe. While his primary focus will be on the restart of operations in Mozambique, Mr Raaff will also be responsible for establishing Australian based revenue streams for the Company.

Mr Raaff brings more than 30 years' experience in Business Management, Project Management, Engineering and Construction in Southern Africa and the Middle East and has held a range of senior roles, including 17 years as Chief Executive Officer (**CEO**) of Subtech Group (**Subtech**).

During his time as CEO of Subtech, Mr Raaff grew revenues in the business from AUD equivalent of \$0.3m to \$50m and was instrumental in the negotiation of the sale of the business to James Fisher and Sons plc whereafter he took up a Board position in the UK listed subsidiary.

Whilst at James Fisher Subtech, Mr Raaff successfully led the bid and subsequent project execution for the Temporary Beach Landing facility for the Total LNG Project in Northern Mozambique. As part of this process Mr Raaff developed extensive relationships with other construction contractors in the area directly aligned with LNG development activities in Cabo del Gado.

RBR Executive Chairman, Ian Macpherson, commented:

*"The restart of operations at the significant LNG projects in the north of Mozambique is gathering momentum and it's imperative that RBR prepares itself to capitalise on this significant opportunity."*
